News from Superintendent Brandt Dick

Thank you to everyone who came out on a foggy evening to participate in a conversation about the state of the Zeeland School District. Attached below are the four options that were presented for consideration. The school board will be reviewing these options and determining which direction to pursue. This is a difficult decision, and one the board is thoughtfully working through to determine what is best for the district and for the students we serve.

Options for Zeeland School District

(In no particular order)

- 1) Make a decision to continue to function as a school district. Work with area banks to secure an operating loan until taxes come in.
 - a. This would likely need to include Reduction in Force action as revenue will be reduced due to decrease student numbers as evidenced by the 26-27 Worksheet.
 - b. If an increase in property taxes is considered, the earliest that vote can take place is November of 2026, which means it would take into effect for the 27-28 school year.
- 2) Seek another district to enter into a Cooperative Agreement to educate the children of Zeeland School District.
(NDCC 15.1-27-1)

15.1-27-16. Per Student payments – Cooperating districts.

1. If any school district receiving payments under this chapter cooperates with another School district for the joint provision of educational services under a plan approved by the superintendent of public instruction, the superintendent of public instruction shall, notwithstanding the provisions of section 15.1-27-03.2, create and assign a separate weighting factor that allows the cooperating districts to receive, for a period of four years, a payment rate equivalent to that which each district would have received had the cooperative plan not taken effect. The Superintendent of public instruction shall compute the separate weighting factor to four decimal places and that weighting factor is effective for the duration of the cooperative plan.
2. A school district that is cooperating with another school district under a cooperative plan approved by the superintendent of public instruction, and which has taxable property located in the same city as the other school district under the cooperative plan, may not be required as part of the cooperative plan to:
 - a. Provide unduplicated grade level services; or
 - b. Share administrative personnel.

On a different note, it was my pleasure to present an award from the ND School Boards Association to Neil Meidinger for 30 years of service on the Zeeland School Board, and to Francis Meier for his 33 years of service. These two gentlemen have dedicated hundreds of hours over the years to support and strengthen the quality of education in Zeeland. They are truly deserving of recognition and gratitude for their many years of service and commitment to the patrons of the Zeeland School District. Thank you!

Meidinger made a motion to approve the agenda, second J. Meier. All Aye.

Minutes were reviewed. J. Meier made a motion to approve the minutes from the last meeting, second Bender. All Aye.

Financial reports were presented. Rossow made a motion to approve the financial reports as presented by the Bs. Mgr. and payment of the following claims, second Meidinger. Supt. Dick suggested having a public meeting to keep the public informed. With decrease in numbers we will be getting less state funding. Bank representative will be asked to attend. He will explain what the future state aid payments look like for 2026-2027 and the challenges that will create. Board was then given options for the school district to think about for our future.

Next meeting will be December 8, 2024 at 7:00 p.m.
